CDR Travels to Boston to Advocate for

Disability Rights

In October, 40 Disability Rights activists from the Rochester area travelled to Boston, Massachusetts to join National ADAPT in advocating for disability rights. ADAPT is a national grass-roots community that organizes disability rights activists to engage in nonviolent direct action, to assure the civil and human rights of people with

disabilities to live in freedom. ADAPT has chapters across the nation, including one in Rochester, that come together to fight for disability rights.

Boston was chosen by ADAPT as the location for an Action because Massachusetts segregates people with disabilities and seniors in institutions. ADAPT and CDR believe that people with disabilities and seniors should have the right to live and receive services in the community. This is why many members of CDR joined ADAPT in Boston – to fight for the rights of people with disabilities and seniors to live in freedom!

While in Boston, activists protested the Judge Rotenberg Center (JRC). JRC is the only facility in the nation that still shocks disabled people as a form of "therapy." The shock devices they use are made on site and the shocks are stronger than police tasers. 90% of the people in JRC are disabled people of color. Activists chose to protest the JRC because we will not sit quietly as people with disabilities are tortured!

Activists also marched to the Health and Human Services (HHS) building in Boston to demand a meeting with the Secretary of HHS to talk about the proposed capping of attendants' hours. Last year, CDR and ADAPT opposed the implementation of the U.S. Department of Labor Companionship Rule changes because we knew it would result in states capping

CDR's Interpreting Services

We are very pleased to announce that CDR now offers Interpreting Services. As of January 3, the Sign language Interpreting Service that was available to the Great Rochester community through Lifespan transitioned over to CDR! This service is now a component of our Deaf and Deaf-Blind Services and is under the supervision of Catherine Stutzman, manager of Deaf and Deaf-Blind Services.

We are able to provide interpreters for health care, social services, government agencies, legal, educational and employment situations and special events. Our Sign Language Interpreting Service is HIPPA compliant and adheres to the Registry for interpreters of the Deaf Code of Professional Conduct.

We also want to welcome to CDR the two schedulers/interpreters who are joining us from Lifespan. They are both interpreters and are well versed and knowledgeable about the scheduling software that Lifespan provided to us.

Staff at CDR, including our IT staff, worked very hard and in close collaboration with Lifespan staff to make this smooth and seamless a transition as possible. We are very excited to offer this new service!

Updates From Rochester Office

This Fall, our Advocacy Team has worked hard to encourage people with disabilities to be active in the political process and to reach out to their legislators on important Disability Rights issues!

In October, CDR joined five partner organizations in hosting our annual Candidate Forum on Disability Issues.
Over 50 people attended the Candidate

Forum to ask candidates from different offices questions about disability issues that will impact their lives. WXXI's Hélène Biandudi Hofer did a fantastic job as our moderator, asking candidates initial questions and inviting audience members to ask questions that mattered to them.

In November, CDR helped individuals identify their polling places, helped to secure transportation for people with disabilities to get to their polling sites, and collected stories from disabled people about their voting experiences. We also sent out Action Alerts urging everyone to contact their legislators to support the Disability Integration Act (DIA) – a bill that would ensure people with disabilities and seniors who are eligible for nursing facility services would be able to receive those same services in their own homes.

We will continue to advocate for the passage of DIA so that people with disabilities have the right to live in the community!

What's New In Albany

- In December CDR's Policy Analyst went before the Assembly Committee on Transportation to give comments on the state of transportation in NYS
- The Albany team hired two new people!

Local & National Updates

- CDR staff protested the film "Shut In" which negatively portrays people with disabilities, outside the Mall at Greece Ridge.
- Members from Advocacy went to D.C. to meet with legislators directly about the DIA and secured eight new cosponsors!

attendant hours which would harm both attendants and disabled people. Massachusetts wrote a brief to the Supreme Court supporting the rule and assuring the court that there would be no negative consequences. However, now that the rule has taken effect, Massachusetts was proposing to cap attendant hours at 40 hours per week. We wanted to make sure hours were not capped, so when the Secretary of HHS walked out of our negotiation meeting, activists blocked every door in the building and held the building for hours chanting "Just like a nursing home, you can't get out!" We did this to demonstrate that we took this matter very seriously and we would not tolerate disabled people being forced into nursing homes because their attendants hours would be capped. Many activists were physically removed by police.

Just weeks after we took over the HHS building, the Massachusetts State Government announced that the state would not cap attendants at 40 hours per week! We are thrilled that our action made a difference!



Christopher Harper's Success Story

My life took a turn on "unchartered" waters when "struck down" by a tractor trailer in January 2006. After the accident I experienced four years of nightmares, being undiagnosed for Brain Injury, PTSD, Sight Loss, and Anxiety. I went through three years of "boot camp" type therapies: occupational, neuro-therapy, and speech in Schenectady, NY.



When I moved to Corning, NY I had a therapist with a background in music. He started listening to my piano music which now and then, became improvisation. My piano music became different than what I was able to do before the accident. Before the accident, I was reading music for piano. I also connected with a pianist who worked with me on piano which continues today. The pianist has helped me "reinvent" myself on the piano with improvisation, creativity, and self-expression of music.

The focus of my success story centers on my CDR Service Coordinator, Rita Maury, the GM at the Radisson Hotel, and staff at the Steuben County Library who have given me the opportunity to express myself through music, believe in me, and encourage me. I was able to produce a video of my piano playing for the Brain Injury Association Conference in Saratoga Springs last June. It was put on YouTube where the video went viral. Of recent, I had a CD of piano music published. It is available through the Southern Tier Library System and the Steuben County Library. I plan to continue expansion of my talent and to produce more improvisational music.

Updates from the Corning and Geneva Office

CDR, with the assistance of the Geneva High School GISEA program created a Harry Potter themed haunted house throughout the whole office. Over 100 community members turned out to walk through our haunted house and collect candy and other treats from our Hogwarts students.
