Offering a neutral meeting place for people looking for a position as a Personal Care Attendant to meet with Consumer Supervisors in the CDPAS Program.



#### **Consumer Directed Personal Assistant Services:**

CDPAS allows individuals with disabilities requiring personal care the opportunity to supervise their own attendant services. The Consumer Supervisor assumes all of the responsibilities associated with being an employer; however, CDR processes attendant payroll and bills Medicaid on the consumer's behalf for all CDPAS services received.

#### For Individuals Who Want to Become Attendants:

Attendants are not required to have prior training or experience to apply for a position with any Supervisor. Some possible responsibilities may include bathing, dressing, cooking, cleaning, feeding, medication management, etc.

Benefits include earning Vacation & Sick Pay, 401k, and Supervisors often offer very flexible schedules.

#### For Supervisors:

Supervisors or Designated Representatives are responsible for recruiting, interviewing, screening, hiring, training, scheduling, disciplining, and potentially terminating their Attendants.
